## REVIEW 9/11/01 TREASON Bush's 9/11 Story is a FRAUD

Just 7-days from now, the anniversary of 9/11: The two planes that were deliberately crashed into the World Trade Center on September 11, 2001, caused a huge explosion, filling the Manhattan skyline with billowing clouds of black smoke, injuring or killing thousands of people. The buildings sustained minor damages, but hours later dozens of huge explosions inside the buildings caused concrete and steel skyscrapers to totally collapse in a controlled demolition, and one of the buildings, Building 7, was not even hit by an airplane. Never in history has a concrete and steel building collapsed from fire damage, but on 9/11/01 there were three fallen down??!! INSIDE JOB !! TREASON!

And people who knew that airplanes would be deliberately crashed into WTC, invested in the U.S. stock market in the days before 9/11 knowing that United and American Airlines stock would soon drop because the aircraft involved in 9/11 appeared to look like United and American Airlines planes.

The 9/11/01 WTC airplane crash is the premise and the root of the U.S. vs Afghanistan and Iraq War, and the coming attack on Iran. Why does Linda Lingle let this treason continue without challenge, without question?

Polls by Scripps Howard and Zogby concluded that more than 36 percent of the American public suspects that federal officials assisted in the 9/11 terrorist attacks or took no action to stop them, and covered up evidence, so that the United States could go to war in the Middle East; and, 16 percent of Americans believe that secretly planted explosives in WTC buildings for demolition purposes, not the burning jets, were the real reason the massive twin towers of the World Trade Center collapsed in controlled demolition fashion. This 9/11 issue could become a political BIG ISSUE if aggressively publicized, but do you hear any candidates for President speaking about the evidence that points to US government agents and military being the Domestic Terrorists who caused the 9/11 attacks? Despite years of relentless media promotion, whitewash, and 9/11 Commission propaganda, the official 9/11 story still can't even muster 50 percent popular support.

A huge amount of evidence points directly at the Bush regime as the perpetrators of this Domestic Terrorist Attack on USA. But a few points provide the strongest evidence available that the Bush "official story" of 9/11 is not true:


1. The North and South Towers of the World Trade Center almost certainly did not collapse and fall to earth because hijacked aircraft hit them. A plane did not hit Building 7 of the WTC, but it also collapsed after owner Larry Silverstein ordered Pull it. All three were most probably destroyed by controlled demolition charges placed in the buildings before 9/11. A substantial volume of evidence shows that typical residues and byproducts from such demolition charges were present in the three buildings after they collapsed. The buildings were also scheduled for demolition, but the EPA required a non explosive method that would have cost billions. And with this terror attack scenario, Silverstein collected more than \$3-billion in insurance claims instead.

2. A large commercial airliner certainly did not hit The Pentagon. Hard physical evidence supports this conclusion; the hole in the Pentagon was dramatically smaller than an airliner would create. The building was hit by something smaller, possibly a missile, or a drone aircraft. Absolutely no information is available on what happened to the original aircraft (American Airlines Flight 77, the crew, the "hijackers," and the passengers. The "official story," as it appeared in The 9/11 Commission Report simply says, "At 9:37:46, American Airlines Flight 77 crashed into the Pentagon, traveling at approximately 530 miles per hour. All on board, as well as many civilians and military personnel in the building, were killed." This allows readers to assume that pieces of the aircraft and some bodies of passengers were found in the rubble of the crash, but information released by the government does not show that such evidence was found. The story put out by the Pentagon is that the plane and its passengers were incinerated; yet video footage of offices in the Pentagon situated at the edge of the hole clearly shows office furniture undamaged. The small size of the hole in the Pentagon wall still remains as valid evidence and so far seems irrefutable proof that no large commercial passenger plane crashed into the Pentagon on 9/11/01.

3. The names of the hijackers were not on the manifests of any of the four aircraft. None of the alleged 19 hijackers' bodies were ever found. Furthermore, at least five of the alleged hijackers have since turned up alive in the Middle East. Nonetheless, the FBI has never bothered to re-investigate or revise the list of hijackers. Does this suggest that the FBI knows that no one in the administration is interested in reopening any further investigations? Do any of the Candidates for President have the courage to direct a criminal investigation?

4. Numerous pilots have testified that none of the alleged 19 hijackers could have flown the airliners well enough to hit the World Trade Center towers and the Pentagon with as much accuracy as was displayed. The debate on this issue simply raises more doubt about the government's charge that the people it has named


as hijackers are the real hijackers.

5. Cell phone calls allegedly made from the hijacked planes are proven to be fabricated, and that technology was not available at the time.

6. No one admits seeing the plane that went down in Pennsylvania. Some suggest that the plane actually landed in Cleveland and that passengers then were whisked away to some unknown destination.




**New C D's**

**New Book**  
**Ha'ena: Through the Eyes of the Ancestors**

**author: Carlos Andrade**



Richly illustrated with archival photographs and portraits of kupuna of the district of northwestern Kaua'i, Ha'ena was known to aboriginal Hawaiians as Hale Le'a (House of Pleasure and Delight). Author Carlos Andrade leads the reader through the ages, examining the stories that identify the origins and places of the earliest inhabitants of Ha'ena. The narrative outlines the unique relationships developed by Hawaiians with the environment and describes the system used to look after the land and the sea. Andrade goes on to research the changes wrought by concepts and perceptions introduced by European, American, and Asian immigrants. he delves into the impact of land privatization as Hawai'i struggles to preserve its independence.

The Mahele and Kuleana Act, legislation that laid the foundation for all landholding in Hawai'i, had a profound influence on Ha'ena.

A little known chapter in the fight to perpetuate traditional lifeways,, the description of the thirty-nine Hawaiians who pooled their resources, bought the entire ahupua'a of Ha'ena, and held it in common from the late 1800s to 1967.

Lastly, Andrade collects the stories of kupuna who share their experiences of life in Ha'ena and surrounding areas, capturing a way of life that is quickly disappearing beneath the rising tide of non-Native people who now inhabit the land.

*Ha'ena: Through the Eyes of the Ancestors* [ISBN 978-0-8248-3119-6, University of Hawai'i Press, pp. 158 should be of great interest to historians, ethnologists, sociologists, and students of Hawaiian culture.



## SUPERFERRY Lawsuit: Lingle conspired with feds against American Citizens

The Ninth Circuit Court of Appeals issued an opinion in the Superferry case filed against the United States Coast Guard.

Apparently, the integrity and credibility of the judges in the court system are challenged when high government officials like Linda Lingle are conspiring to break the law. [similar to 9/11/01 treason attack coverups].

The decision of the appellate panel says in part: Plaintiff-Appellants ("Appellants"), many of whom participated in protests on August 26 and 27, 2007, oppose the Hawaii Superferry's ("HSF") operation to the Nawiliwili Harbor in Kauai, Hawaii, alleging that it is illegal." Opinion at 12377.

Plaintiffs-Appellants further alleged that the highest officers of the State government [Linda Lingle/Mark Bennet et al] in league with federal and local law enforcement conspired to facilitate Superferry's illegal operation.

Plaintiffs-Appellants also alleged that in the course of the conspiracy, law enforcement officials broke the law with false arrests, theft, robbery, assault, and battery.

Finally, Plaintiffs-Appellants alleged that the government conspirators engaged in terroristic threatening in an attempt to prevent citizens from enforcing the law to stop Superferry's illegal operations.

The case specifically challenged the United States Coast Guard's adoption of a security zone to protect Superferry's illegal operation.

The appellate panel deciding this case did not address any of these issues. The central issue presented by Plaintiffs is acknowledged and then ignored in the opinion. The decision addressed the First Amendment aspect of the protest mounted by some of the Plaintiffs-Appellants and did not address the law enforcement aspect of that protest. Those who entered the waters of Nawiliwili Harbor on August 26 and 27 to block the Superferry did so because they understood that the Superferry could not operate legally in light of the decision by the Hawaii Supreme Court requiring preparation of an environmental assessment prior to any operation.

This omission from the opinion is a critical failure. If the operation of Superferry was illegal, the Coast Guard could not legally adopt a security zone.

The Plaintiffs will be discussing options which include:

- dismiss all remaining issues in the case (no appeal)
- file a motion for reconsideration with the deciding panel
- file a motion requesting an en banc hearing (larger panel of 9 Circuit judges)
- file a writ of certiorari requesting the Supreme Court to take up this case.
