Molokai Kaluaaha Church Restoration Work Continues



Historic Congregational Church Dedicates New Roof

Members and supporters of the Kalua'aha Congregational Church, "The first Church on Moloka'i, Established in 1832" celebrated the dedication of a new roof that was recently built inside the walls of the church's largest building which dates back to 1844. The historic church was the mother church of Molokai and served as the center of Congregational activity on the island.

The present-day structure is the third building serving the United Church of Christ membership in the Kalua'aha area. In 1843, with a membership of more than 1,200, new building plans were made, materials collected and in 1844, the present structure, then consisting of a 100' by 50' stone structure with 2 1/2 feet thick walls rising 18-feet high, of timber, stone and lime was completed. Members had gathered materials for the building, which included four double doors and a single door with eight windows, 18 lights each and two windows with 12 lights. A thatched roof covered the worshippers.

By 1917, church repairs were made with buttresses were added and walls were thickened. The church was rededicated after repairs were made. In 1964, under the inspired leadership of Mrs. Rachael Puailihau, the small congregation began a campaign among themselves to restore the structure. Each of the 21 members pledged \$5 a month. In 1967, the campaign gathered momentum and wider publicity in 1967. A storm in May, 1967 emphasized the need for restoration when, only two weeks after the bronze bell had been removed, the steeple collapsed. (*Star-Bulletin*, May 27, 1967). Restoration work began in 1968, Mrs. Puailihau's health curtailed her vital leadership and financial help dwindled.

In December, 2000 a worship service of rededication was held with Kahu David K. Kaupu leading members of the Kalua'a Church. Family Members of Congregational missionary Revered Harvey Rexford Hitchcock, and UCC Council members from other islands. Since then, Kalua'aha members have held services in the walls and restored floor under a tent, continuing with plans to maintain the grounds. Plans to restore the bronze bell are continuing.


On Sunday, September 27, 2009, on the Seventeenth Sunday after Pentacost, a Ceremony to Dedicate the new roof was held. A study corrugated roof was dedicated by Kahu David Kaupu with Kalua'aha Moderator Stella Iaea untying the ti-leaf lei. With remarks about the importance of the Ti plant to Hawaiians and leading the singing of "Ho'onani I Ka Makua Maui", the new roof was dedicated. Auntie Stella gratefully described the work by Contractor Lloyd Inouye, the many hands and hearts who helped with preparations for the day's event.

Topside Kahu Fe Ayap gave the sermon "Courage for Community", saying, the new roof allows her to be heard all the way to the back of the church, without a microphone. First baby baptized into the Church under the new roof was Darin McCutcheon.

Fellowship, reunions and a *pa'ina* followed the morning service. The next Joint Service will be held on October 25 at Kalaiakamanu Hou Church at 10am. On November 7, the Topside Bazaar at Kalaiakamanu Hou Church is a joint project of all four Topside UCC Churches. [More photos page 5]

Agriculture on Molokai Means More than just Taro



PonoFarm agriculture products of Waialua, Molokai includes taro of course, its the local Hawaiian culture. Just as important to local food markets and restraunts like FMC and Big Daddy's are the small quantities they purchase of high quality lemons, papaya, squash, pumpkins, star fruit, tomato, egg plant, Dragon's Eye fruit, bananas, corn, bitter mellon, tangerines, mangoes, avocados, ginger, pepers, and much more—that is Aspergrass to Zukini— that are produced by George and Susan Peabody at Pono Farm in Waialua. [Family dogs "Hapagirl" and "Tiger" are tasked with the big job daily of rat control.]

PonoFarm is representative of just a handfull of small scale agriculture operations in east Molokai, but George and Susan also offer green waste recycling, tree chipping and trimming as part of their agriculture activities.

The biggest problems are fruit flies and cost of water, says George. Some of the other local farmers have free water from streams, but we mulch to save H2O.

Gun Control Will Violate Your Rights

Open Letter to the NRA Board

It is essential to attack the concept of "gun control", to show that this is a blood drenched concept, that has no place in any civilized country. The NRA's strategy - of compromise - is failing. Appeasing the "gun grabbers" with offers of compromise whets their appetite for more "gun control" measures.

Some of you may even have figured out that a man with a gun is sovereign, an unarmed man is a lowly subject. Unless the NRA changes its strategy, the law abiding firearm owner will go as the Jews in Nazi Germany: extermination.

This strategy will continue to fail because it is based on one wrong assumption. The FATALLY bad assumption is that SOME forms of "gun control" -e.g., the "instant check" are, or can be, a socially useful policy, or at least not socially harmful. This is wrong. Dead wrong.

"Gun control" is an extremely destructive policy. It helped clear the way for Nazi ascendancy in Germany. As a result, 13,000,000 people were murdered; 2700/day, each day that the Nazis were in power (30 January 1933 - 7 May 1945).

The NRA to mobilize the bulk of the population, must abandon the policy of compromise on "gun control". The NRA must be bold and aggressive. It is not enough to focus on leading "gun grabbers". The NRA must turn its back on its 60 years of trying to reach a compromise with the "gun grabbers".

To that end, the NRA should:

1. dump the notion that the Second Amendment has ANYTHING to do with hunting: hunting for food is tradition, but the Second Amendment was written to protect American Citizens from corrupt politicians, enemies of the Constitution, and JPFO's research has shown that "sporting purpose" was almost certainly lifted from the Nazi's Weapons Law of 18 March 1938;

2. go directly to the public via bill-boards, newspaper ads, radio ads, TV ads, and shift money away from lobbying law-makers with free lunches;

3. tell the American public that their local police force does NOT have - and never had - a duty to protect the average person, according to the U.S. Supreme Court; that such a duty cannot exist because we cannot possibly have enough police officers; the cost would bankrupt us, and so large a number of police officers would extinguish freedom; even the concept of "gun control" is ultravires;

4. emphasize that if criminals' misdeeds are used to define the freedoms of the law-abiding, then America will shift from being a democracy to a criminocracy, to a country ruled by the tiny, vicious minority;

5. tell the American public that the biggest murderer, by far, in this century has been governments "gone bad", look at Clinton, Bush, and Obama, and that the information age makes it easier for governments to commit mass murder;

6. U.S. troops would not be needed in Haiti, Somalia, Rwanda, and Yugoslavia to prevent, or end, mass murders if each of these countries did not have "gun control" under which the average person there was disarmed.

NRA must tell Americans, and the World that there is a very evil down-side to "gun control". The down-side is rule by criminals with badges and uniforms and guns who seize control of a government, taking all rights and many lives.

To those of you who are inclined to think, "It can't happen here", I would point out that just over 50 years ago, Americans allowed all but the final step of a genocide. On 19 February 1942, President Roosevelt signed Executive order 9066. Under this order Japanese-Americans were sent to concentration camps, and held behind barbed wire fences by machine gun toting guards. All were deprived of homes, businesses, and most of their personal possessions. The U.S. Supreme Court even approved it. (see Korematsu v. U.S.). **Huka wai i ke pili !**

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!



Obama's War Criminals Accused of Killing Civilians

Federal Prosecutors Say Blackwater 'Specifically Intended to Kill' Civilians
The US government's allegations back-up the explosive testimony of two former Blackwater employees. Gov't says Blackwater employees shot Iraqis as "payback for 9/11"

A month ago, most major, corporate media outlets ignored the sworn statements of two former Blackwater employees, one of whom—identified in court papers as John Doe #2— alleged that the company's owner Erik Prince "views himself as a Christian crusader tasked with eliminating Muslims and the Islamic faith from the globe," and that Prince's companies "encouraged and rewarded the destruction of Iraqi life." Most media outlets ignored the numerous, specific allegations contained in the sworn affidavit of John Doe #1 about Blackwater operatives shooting at defenseless civilians—most of them based on John Doe #1's personal experience working in Iraq for Blackwater.

Now, it is not just former employees making these allegations.

On September 7, federal prosecutors in Washington DC submitted papers in the criminal case against five Blackwater operatives for their alleged role in the 2007 Nisour Square shooting in Baghdad that killed 17 Iraqi civilians and wounded more than 20 others. Blackwater forces "fired at innocent Iraqis not because they actually believed that they were in imminent danger of serious bodily injury and actually believed that they had no alternative to the use of deadly force, but rather that they fired at innocent Iraqi civilians because of their hostility toward Iraqis and their grave indifference to the harm that their actions would cause," the US Attorney alleges in court papers submitted by Kenneth C. Kohl, the lead prosecutor on this case. "The defendants specifically intended to kill or seriously injure the Iraqi civilians that they fired upon at Nisur Square."

The allegation that stands out most in the court filing, as Mother Jones noted, is this one against one of the Nisour Square defendants: During the twelve months proceeding the events charged in the indictment, while assigned to the Raven 23 convoy operating at various locations in the Red Zone in Baghdad, Iraq, defendant Nicholas Slatten made statements that he wanted to kill as many Iraqis as he could as "payback for 9/11," and he repeatedly boasted about the number of Iraqis he had shot... [During these 12 months,] Slatten deliberately fired his weapon to draw out return fire and instigate gun battles in a manner that was inconsistent with the use of force and escalation of force policies that governed Blackwater personnel in Iraq. Here are some other key excerpts from the court document:

The United States will introduce evidence that in the year leading up to the events of September 16, 2007, several of the defendants had harbored a deep hostility toward Iraqi civilians which they demonstrated in words and deeds that bears directly on the defendants' respective states of mind when they fired rounds at innocent civilians at Nisur Square on September 16, 2007. In addition to verbal expressions of hatred towards Iraqi civilians, the defendants engaged in unprovoked and aggressive behavior toward unarmed Iraqi civilians in Baghdad.

During the twelve months proceeding the events charged in the indictment, while assigned to a turret gun position on the Raven 23 convoy operating at various locations in the Red Zone in Baghdad, Iraq, defendants Paul Slough, Nicholas Slatten and Evan Liberty routinely threw water bottles and other items at unarmed civilians, vehicles, wagons, and bicycles without justification in an attempt to break automobile windows, injure and harass people, and for sport.

On or about May 23, 2007, in the vicinity of Amanat City Hall in Baghdad, Iraq, near an intersection of the city known to Blackwater personnel as "Grey 55," defendant Evan Liberty discharged an automatic weapon from the turret of a Blackwater armored vehicle without aiming the weapon, and without regard for who might be struck by the rounds, and that was inconsistent with the use of force and escalation of force policies that governed all Blackwater personnel in Iraq.

Federal prosecutors reject any suggestion by Blackwater or the defendants in this case that the men at Nisour Square acted in self-defense in response to an attack by "insurgent," as Blackwater alleged from day one. "None of these victims was an insurgent, and many were shot while inside of civilian vehicles that were attempting to flee" Blackwater's operatives, prosecutors allege.

PETA's Good NEWS: Chemical Companies will reduce cruel animal testing

People for Ethical Treatment of Animals [PETA] has held meetings with top chemical companies, and through one of these meetings PETA members learned that a massive animal testing program in Europe was going to cause even more animal suffering as a result of duplicative testing. PETA therefore coordinated a joint letter from PETA, PETA Europe, and European animal protection groups to the European Chemicals Agency (ECHA), which oversees the program, asking that it intervene, and explained how the duplication could be avoided.

Now, in a huge victory for animals, ECHA has announced a process that will spare as many as 4,410,000 animals from these cruel tests! ECHA responded by instructing chemical companies not to conduct initial toxicity tests on animals if they were proposing to conduct more comprehensive tests on animals during later stages of the program. Thanks to your support, more than 4 million animals will be spared the agony of being force-fed toxic chemicals over and over again via a tube inserted through their mouths and into their stomachs, a terrifying and painful procedure for the dogs, cats, rabbits, mice, rats, pigs, and others.

HMSA Denies Hawaii Woman Transplant Because Medical Marijuana

Waimea, Hawaii, resident Kimberly Reyes died July 27 at Hilo Medical Center, 10 days after her insurance provider denied the liver transplant she needed because she had tested positive for marijuana in a series of toxicology tests. Reyes was not a registered medical marijuana user, but her family said she had used it to deal with nausea, pain, and disorientation caused by the hepatitis.

Reyes' husband Robin, and her mother, Noni Kuhns, said the rejection by HMSA was based on failure to comply with a policy prohibiting drug use, but that neither HMSA nor her doctors had told her just what that policy was.

"Just because someone takes a hit off of a joint doesn't mean that it should be the end of their life -- this is not a reason to deny life," said Kuhns.

HMSA has refused to comment or provide a copy of their policies on drug use and transplant approval.

Denial of transplants to marijuana users has happened before. Last year, Seattle-area musician Timothy Garon died after being refused a transplant because of doctor-recommended medical marijuana use. In 2003, Oregon resident Dave Myers was removed from a transplant list merely for Marinol, a prescription medicine related to marijuana.

It is OK though to abuse your liver with alcohol until it can be used as a doorstop.
