Producer of video America: Freedom to Fascism Patriot Hero Aaron Russo Passes Away Expose of IRS and 9-11

Local hunters are angry and wonder by TNC plans to bring in foreigners to hunt and manage wildlife on the island of Molokai. Worse yet, it looks like TNC is excluding the local community from the process, wrote Walter Ritte.


"N/C has insulted our hunters by bringing in outside hunters to manage our wildlife, which is an important part of our economy. N/C have ignored our state constitution and HRS laws, which protect Native Hawaiian Gathering Rights. Hawaiians have not had a chance to comment on the impacts this new program will have on their economy....The Molokai Hunters Association (MHA) is trying to avoid a dangerous confrontation with the private New Zealand Pro Hunt group, which N/C has hired to manage the wild life on Molokai." Ritte wrote.

Ritte as asked TNC to meet with the "indigenous people and traditional communities" of Molokai to receive their input; TNC to take a "collaborative approach" on Molokai; TNC to seek avenues to include Molokai residents, particularly theMolokai Hunters Association in your wildlife management activities.



The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!







Gun Rights Prohibited to Vets? Makaala: HR 2640 by McCarthy

When the Veterans Administration got caught adding veterans' names into the NICS system during the Clinton presidency, they defended their actions by saying it was "required by law" -- a statement which was just flat out false.

But it's notable to hear what a spokesman for the VA said in an interview with WoldNetDaily (June 27, 2000). He said the most common way of finding a veteran "incompetent" is when he or she receives a formal rating of incompetency from a VA panel of medical representatives or from "a duly authorized VA medical center, government agency, or even a PRIVATE PHYSICIAN."

That's what HR 2640 is all about.

McCarthy and Leahy (and others like Sen. Chuck Schumer) are forging the legal chains that will be used to keep hundreds of thousands -- if not millions -- of decent, law-abiding Americans from owning guns... not because of what a court rules, but because of what ONE INDIVIDUAL says.

Over two hundred years ago, Patrick Henry warned about the "chains" that were being forged to enslave them. If he were here today, would he fight it?

Thankfully, there are many of you who are sounding the alarm. State groups from all over the nation are pumping out alerts to supplement what GOA is doing at the national level. Just yesterday, the New Hampshire Firearms Coalition (NHFC) called its members to action, stating that HR 2640 is a Trojan Horse, which sounds justified on the outside with promises of keeping "mental defectives" from having firearms. But when one takes a closer look at the details of the bill, the group said, it reveals "a huge expansion in those who will become a prohibited person; an expansion that could potentially include most Americans."

MOLOKAI VET CENTER \$250,000

At a recent official Veteran hearing, comments were made that need clarification. Molokai Veterans own a piece of property free and clear with no strings attached. There is a public tax key number under The Molokai Veterans Caring for Veterans. The Molokai Veterans are trying to raise money to build a permanent Veterans Center on the property. There are Veterans that support the MPL plan and there are Veterans that oppose the MPL plan. Veterans have fought and died for all to have the right of free press, free speech, and freedom of opinion.

No!..Molokai Ranch will not build our building. No!..Molokai Veterans are not going to move to the Armory, it belongs to the Molokai National Guard. The Molokai Veteran organization has grown and the Vet center is getting smaller and bags are getting less...we need a larger and permanent home. Early this year, six Molokai Vietnam Vets with the help of Representative Mele Carroll lobbied the State Legislature for \$3 million. The legislature gave us a grant for \$250,000 which the Governor has not yet released. Prior to her being elected, she sent the Molokai Veterans a letter saying she would try to get \$3 million for our building. Not even close..There has been millions of dollars of state money given to Veteran organizations on the Big Island, Maui, Kauai, and Oahu.

We are prepared to change our plans--use the \$250,000 plus raise other money to build our Center Molokai style. The Molokai Veterans would like to stay out of As the World Turns of politics with MPL and others in community.

Again thank you Peter Nicholas and MPL for the gift of the land: no strings attached. To political insurgents and wanna-be sabotegers, Vietnam Vets can see a potential ambush and, if needed, we will protect the integrity of all veterans.




