Hawaiian Language Funding Cuts Protested

Protest held Aug. 22 from 7:00am to 2:00pm by students and parents of the Molokai Hawaiian Language Immersion Program.

Molokai High School and the Middle School made dramatic cuts in the program with out input and consultation with the parents. The parents are afraid this is the beginning of the end for the popular program which has produced outstanding results for their children. The administration cut the staffing to one teacher for the High School and one for the intermediate, and the parents are demanding more staffing.

Preamble to the Bill of Rights

The Conventions of a number of the States, having at the time of their adopting the Constitution, expressed a desire, in order to prevent misconstruction or abuse of its powers, that further declaratory and restrictive clauses should be added; And as extending the ground of public confidence in the Government, will best ensure the beneficent ends of its institution:

9-11 Firefighters, Volunteers, Police, Rescue Dogs, Investigators Now Suffering Effects along with Iraq and Afghanistan Vets due to toxic pollution and Radiation and shots: REVIEW the TREASON Against VETS

Molokai resident Lt. Richard Smith, USN ret. was a victim of military testing of radiation and biological agents in the 1960's, suffering cancers and other ailments. He is concerned for all veterans used in the secretive military policy of chemical testing, the need for better care for vets, and educating the public about such unethical operations against American citizens.

Having moved back to Molokai and living with his deceased wife Sadie Wallace's family for a while, Richard told The MAN that he served on the USS Granville S. Hall [YAG40] from 1965 to 1968 as an engineering officer. His ship was exposed to heavy radiation before he came aboard while in Operation Crossroads, Castle, Wigwam, Redwing, but he soon exhibited signs of radiation sores on his face. But that is not all. His ship was used for testing Biological and chemical warfare agents in 1968 at Enewetok Atoll. He is also concerned about the other ship, YAG 39 George Eastman with five tugboats that were used for bio/chem testing. He says he can get no informations now from the military to support claims of service disability, not even records of immunization shots given as medical records. Vets with related medical problems have no place to turn.

Richard asks anyone with knowledge to add to his, and how to access some assistance from the Veterans Administration to clear up the record and get help for vets to contact him.

Part of the story became public knowledge in 1996 when the Pentagon admitted that Pesian Gulf War vets had been exposed to chemical and biological weapons when they blew up ammunition dump in Iraq full of the chem/bio weapons supplied to Saddam Hussein by the US and Allies. The military had lied to vets about the toxic effects just lie they lied about Agent Orange in Viet Nam, and radiation from Depleted Unarium ammo that was used by the US in the 1991 War on Iraq.

TESTing! TESTing!: GMO; VIRUS spray


On Friday, August 18, 2006, the FDA approved a viral cocktail to be sprayed on foods we eat. This is the first time viruses have been approved for use as food additives. The FDA wants you to believe it will be safe to consume these viruses every day for the rest of your life with no adverse health effects.

Not surprisingly, the FDA doesn't want you to know which foods are adulterated in this manner, for fear you may not buy them; thus, no labeling will be required. This is a monumental announcement by the FDA, indicating they are throwing all caution to the wind regarding the safety of our food supply.

Are you willing to stand in line for a virus-laden sandwich? How do you like the idea of buying virus-infested food for your family? The first virally contaminated foods entering our food supply with the blessings of the FDA will be luncheon meat and poultry. 

AKAKA , INOUYE and CASE Vote Against Gun Rights guilty police still at large

Senators Akaka and Inouye vote against your right to keep and bear arms during emergency. In mid July, 16 U.S. Senators violated their oath of office ("to preserve, protect and defend the Constitution"), by voting to allow the government to confiscate your personal firearms during an emergency.

It's a familiar list of suspects including Akaka (D-HI); Inouye (D-HI) on the record voting against our right to keep and bear arms.

With lawlessness run amok after the Katrina disaster, government officials' response is to disarm the victims and leave them defenseless. Now, Akaka and Inouye want to give Lingle's Hawaii Police State officials the power to disarms Hawaiians during an emergency. Just like Katrina in New Orleans where police announced that only police and military will be allowed to have guns, the Constitution notwithstanding. The Citizens will just have to rely on government to protect them, even though police were not where to be seen when Citizens were being attacked by thugs and gangbangers. Those lucky Citizens who did have guns successfully fended off the criminals, only later to be assaulted by police and military to take away their firearms then needed to protect themselves. The police who did this have not been arrested, though some of the guns they took by force have been returned. This should never happen in a free country. The fact that the perpetrators are known police officers, yet still at large, is a national disgrace.

Kill the McCarthy Gun Registration Federal Funding in Hawaii's Growing Police State

Gun Owners of America has alerted you on a couple of occasions to a massive gun control bill that is currently working its way through Congress. H.R. 1415, introduced by New York anti-gun liberal Carolyn McCarthy (D), authorizes nearly \$1 billion to the states to vastly expand upon the unconstitutional gun laws already on the books.

H.R. 1415 passed out of the House Crime Subcommittee in May, and is slated to come before the full Judiciary Committee sometime in September. If passed, the billion dollars will be used to computerize and make available to the federal government millions of state records that could include state tax returns, employment records, library records (we've already seen how these have been deemed relevant to terrorism investigations), DMV, hospital, mental health and some misdemeanor records -- all in the name of making sure you're not prohibited from owning a gun. Oh, right!?!?

In all, this bill allows for an enormous data dump from the states to the federal government, at the same time laying the infrastructure for even more gun control in the future. No wonder this bill has leading anti-gunners in Congress frothing at the mouth. The sponsor of the bill, as noted, is one of the most virulent anti-gunners in Congress.

Of the 32 cosponsors, 31 are rated "F" on GOA's scorecard; one is rated "D." These representatives support the bill because it enhances their gun control agenda.

Also supporting this anti-gun rights bill are anti-Second Amendment groups like the Brady Campaign and Americans for Gun Safety (AGS).

H.R. 1415, perhaps the most massive expansion of gun control since the Brady bill passed in 1993, is not a bill that should be supported by pro-gun conservatives.

Gun Owners of America is the only national gun group opposing this bill. If you don't act quickly, your representative will hear only voices of support for this monstrosity, but then Ed Case is already a known anti-gun rights quisling fascist.

Crimes of Politicians Must Be Stopped by The People (You are The Militia)


