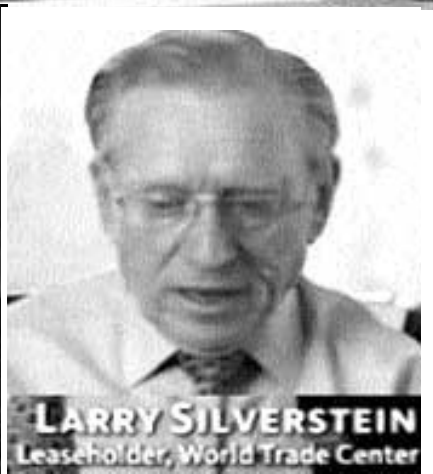

## Breaking News: Molokai Literally Under Fire, Again!



This week about 8,000 acres of dry pasture and forest lands burned mauka of all the residential areas of Kaunakakai, Kalamaula, the Heights, and all the way east to One Alii fishpond area. Local residents's homes were threatened and they took to the garden hoses, moved boats and pets out of harms way, and evacuated some areas, to prevent damage and loss of life. Three helicopters from Maui joined Molokai firefighters and local residents to put out fires that came within a few feet of homes. Later, firefighters from across the state were flown in to assist, and expected to extinguish the fire sometime later this week.

The point of origin behind Ranch Camp is being investigated, as well as the unusual spreading of the fire in both east and west directions.

## Obama case on Trial October 5

The hearing of a Motion by Dr Orly Taitz for Discovery of records showing relevance to eligibility of Barack Obama was held Sept. 8, and Judge David Carter today tentatively scheduled a trial for Jan. 26, 2010. The case challenges Barack Obama's eligibility to be president based on questions about his qualifications under the requirements of the U.S. Constitution to be a "natural born citizen".

But judge Carter did not rule on Taitz' motion to be granted discovery – that is the right to see the president's still-concealed records. Nor did Carter rule immediately on a motion to dismiss the case, submitted by the U.S. government attorneys representing Obama. Instead, Carter ordered a hearing Oct. 5 on the motion to dismiss and ordered arguments submitted on the issue of discovery.

If Taitz's case survives Oct. 5 challenge as expected, a pretrial hearing has been scheduled for Jan. 11 and the trial for two weeks later on January 26, 2010.

The biggest news is that Obama did not rebut charge he was born in Kenya and his motion to dismiss was NOT granted. This means Obama's team is required to produce the proof needed to prove he was born in Hawaii of two parents who were American Citizens, or at least satisfy judge Carter of his Constitutionally required "natural born" status. The known facts are that Obama was born a British subject; His father was NEVER a U.S. Citizen; and his mother was just 17 years old.

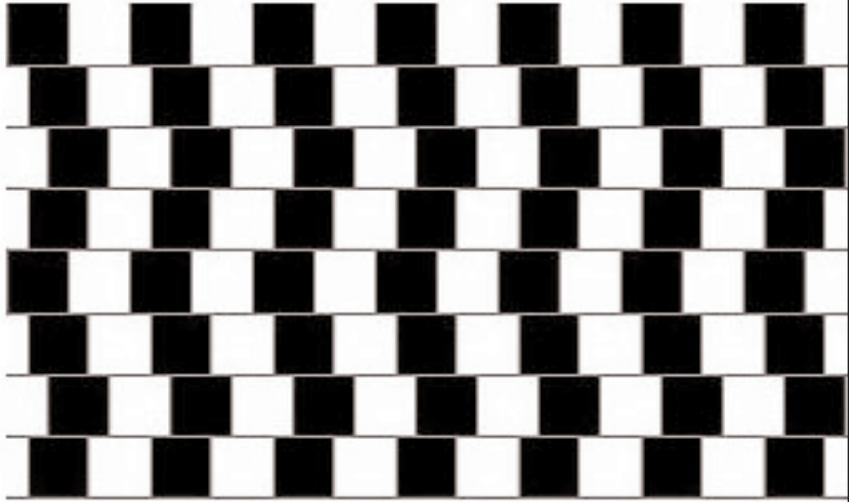

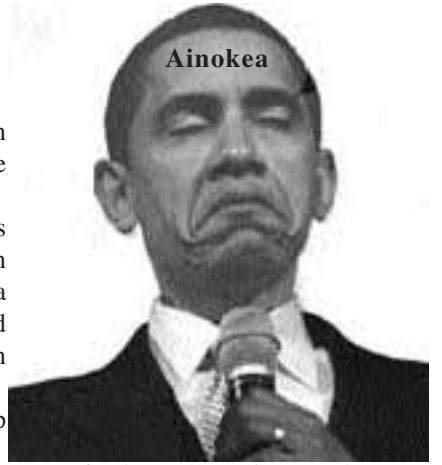

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

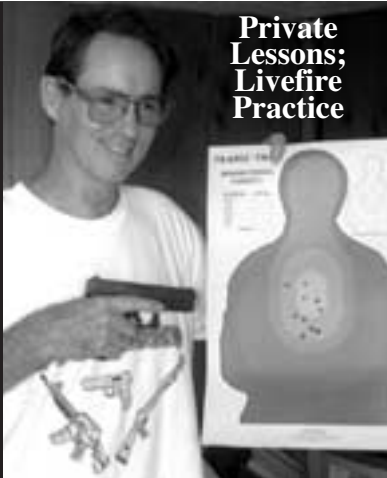

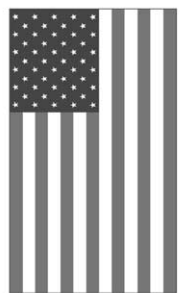

## DLNR Rules Violate Rights

Dear DFW Hunting Coordinator:

Thanks for the letter regarding DLNR enforcement of leash laws for hunting dogs in Public Lands for the protection of the NON-HUNTING people and pets also using these public lands.

It is NOT a "minor problem" when hunting dogs running loose on public trails attack hikers or a pet on a leash and the pet's Owner who is trying in vain to prevent the out of control hunting dogs from tearing the pet into bloody pieces. The dead pet, extremely terrorized and ripped to shreds, and the Owner of the pet also injured in the futile attempt to defend the pet and himself without the force of firearms vehemently disagree with your claim that it is a "minor problem".

Such incidents of unleashed hunting dog attacks on pets and people in public forests and trails may be infrequent, thank God, but they are horrific, tragic, traumatizing, and they are easily preventable.

1. DLNR rules/regs do not prevent licensed hunters from bearing arms for killing animals they hunt, and for their self protection while on public lands. But those same DLNR rules and other statutes, contrary to the 2nd Amendment of the Constitution for the United States of America that guarantees the Right of the People to keep and bear arms, makes NON-HUNTERS subject to arrest and criminal prosecution for bearing arms for self protection and protection of pets and other persons while in those same public lands. Therefore, the DLNR/DFW must immediately correct their rules/regs to support the Right of every person to keep and bear arms for protection from all dangers, including unleashed hunting dogs, however infrequently such dangers are encountered, by specifically incorporating the 2nd Amendment and equality under law for all persons utilizing the public lands. Onscene, real time, individual enforcement and self protection with firearms from attacks by hunting dogs and other dangers must be supported by DLNR, not infringed, in addition to the good intentions of the largely unenforceable hunting dog control rules.

2. Prohibit the use of unleashed dogs for hunting purposes. It is pure cruelty to animals [both dogs and prey] and encourages the unskilled hunters who feel the need for an easy kill instead of doing their own tracking and pursuit of their intended victims. Only whimpypass lazy killers need to use dogs in addition to their bait pits and 4-WD's to terrorize, chase down and immobilize deer and pigs so they can then blow their brains out with high powered guns at close range and/or stab them to death while the pack of dogs hold the victim down by the ears, snout, legs, tail. Whimpypass lazy killers are also the most irresponsible and fail to control their dogs. Their unleashed hunting dogs immediately become a threat to public health and the life and welfare of other people and pets, livestock in the forest who are unprotected from these unleashed hunting dogs.

3. Yes, I know, its a tradition and way of life etcetc. So refer to #1 above: .... DLNR/DFW must immediately correct their rules/regs to support the Right of every person to keep and bear arms for protection from all dangers, including unleashed hunting dogs, however infrequently such dangers are encountered, by specifically incorporating the 2nd Amendment and equality under law for all persons utilizing the public lands. Onscene, real time, individual enforcement and self protection with firearms from attacks by hunting dogs and other dangers must be supported by DLNR, not infringed, in addition to the good intentions of the largely unenforceable hunting dog control rules.

The dangers caused by hunters with unleashed hunting dogs will continue to discourage most of the non-hunting public from experiencing the wonderful Nature of public lands in Hawaii with their pets, simply because the DLNR has not provided for equal rights and protections to all the People, a responsibility that is incumbent upon the State of Hawaii. Please keep me informed of your efforts to correct this inequity, and this dangerous situation, and the infringement of my 2nd Am Right to keep and bear arms, i.e., "...shall not be infringed."
