In fact, according to the Centers for Disease Control and Prevention (CDC), A-H1N1 has gene segments from North American swine, bird and human flu strains and a segment from Eurasian swine flu.

## Vindictive SWAT COPS KILL PEOPLE and Pet DOGS for NOTHING !

"Tactically, those SWAT units are quite impressive, but they're vastly over-used," said Peter Moskos, an assistant professor of Law, Police Science, and Criminal Justice Administration at the City University of New York's John Jay College of Criminal Justice, former Baltimore police officer, and author of "Cop in the Hood." "The problem is once you've got those units, you're going to use them. Their goal is to have overwhelming force and have all the cops live, but innocent people die," he said.

Law enforcement can have it both ways, said Balko, author of *Overkill: the Rise of Paramilitary Policing in America* "If not many police are being killed in drug raids, they can say these tactics are working," he said. "If more are being killed, they can say this is why they need to be more aggressive."

Drug squad cops are a special breed, said Moskos. "Many cops never would want to work in one of those units," he said. "Even though the raids are pretty safe, they do more dangerous things like undercover operations. These guys tend to be whiter, more conservative, and guys who like breaking down six doors a day.

In the drug squads in particular, they really tear it up. There is a certain vindictiveness; they think 'these people are assholes, they deserve it.'" [Sounds like MPD's DARE cop Stafford Caparida and a few others who disregard the Constitutional limitations on their police powers and the sovereignty of the People]

### MPD DARE Cops Practice



### More DRUG War Tyranny

Treason, the violation of Oath to preserve, protect and defend the Constitution, is a high crime. Is this what we want out MPD officers doing to Molokai residents? DARE is a grant money scam for MPD, promotes crime.

"Nobody has to be killed at all if they would just legalize the drugs," said David Doddridge, a 21-year veteran of the LAPD who rose to the rank of narcotics detective before he retired in 1994. "When I first started, we used to go to roll call, and they would tell us who has warrants, and we would drive out there and knock on the door. Then we went to a narcotics bureau, and we worked in teams, with battering rams," he recalled. "More citizens died than police," Doddridge said.

"I spent several years down in South Central kicking in doors and raiding homes, and probably served 50 search warrants," said Doddridge. "We weren't SWAT, just a couple of narcotics detectives with our vests on, and none of us got seriously injured. There was seldom any resistance."

Narcotics could be dangerous, Doddridge said, but not because of the raids. "The raids themselves are not very dangerous, more a danger to civilians," he said. Now, there are thousands of SWAT teams across the country. They don't have a lot to do, so they end serving drug warrants now."

It's a fool's errand, said Doddridge, who has, since his retirement, joined Law Enforcement Against Prohibition (<http://www.leap.cc>). "After a year or so of doing those drug busts, I thought it was crazy. We weren't doing any good. And I thought about the looks of the faces on those families, the children crying when we're dragging their Dad or their brother out. I thought to myself what are we doing? -- these weren't real criminals out robbing and attacking people. I started feeling really bad about all that. It wasn't until the 1970s that we got all obsessed about drugs. I think we should just treat it like other minor crimes. One problem is the productivity of drug squads is measured by how many doors they knock down.."

Eliminating outdoor drug markets would help, too, Moskos said. "If you're worried about the violence there, you have to push it indoors, off the street. Fear of arrest and raids on their homes push dealers into the street, but maybe we could call a truce. Close your blinds, keep the music down, act like a good neighbor, then we could leave you alone."

## Stop the SWAT Terrorism in USA

Originally created to deal with emergency or other very-high intensity situations (e.g. snipers, hostages, barricaded suspects), SWAT teams were seldom deployed in all of 1980. Today, SWAT teams conduct raids more than 50,000 times per year, mostly while doing low-level drug enforcement.

This is wrong. Every time police enter a home with sudden, overwhelming force in the way that SWAT teams are trained to do, a trauma is caused to the people inside from which they may never recover. Many of the buildings targeted house completely innocent people -- roommates, spouses, children, victims of wrong address reports -- and the vast majority are low-level offenders at worst.

Even more troubling, using a SWAT team when a situation is not already close to violence risks creating an altercation that could otherwise have been avoided. Reports have detailed numerous cases in which unarmed people were shot by police officers who had become trigger happy due to the rush of doing a dynamic entry. In some cases police officers have themselves been killed doing SWAT raids, by people inside who were taken by surprise and who in fear of losing their lives opened fire. SWAT officers killing pets are common, routine.

SWAT goons have no respect for the 4th Amendment: the right to be secure in your home. SWAT goons have no respect for American Citizens right to keep and bear arms for self defense against treasonous government agents. The inappropriate use of SWAT teams is an injustice that shatters the peace of communities rather than protecting them; and the rationale behind most SWAT raids -- fighting the drug war, and protecting police from violence during SWAT dynamic entry raids -- is a farce, a scam, a fraud, given the failure of supply-side enforcement to reduce the availability of drugs.

### We must immediately control SWAT by the following:

- the limiting of SWAT team deployments to emergency or otherwise very-high intensity situations;
- changes in the way criminal justice funding is allotted for SWAT raids, in order to focus on public safety needs rather than arrest numbers;
- stop other policies that have encouraged the overuse of SWAT squads;
- require detailed reports on the activities of SWAT teams and their results;
- policymakers at the federal and state levels to consider the detailed recommendations on this issue appearing at <http://www.swatreform.org>.

SWAT teams should be available but rarely used.

Please take action to fix this problem, in the states and across the nation, for the sake of safety, good policing, basic fairness, and most importantly the protection of Life, Liberty, Freedoms guaranteed by the Constitution for the united States of America and Bill of Rights.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!





## MPD's Bad Cops' names Not Released?

**Nine Maui police officers suspended last year**

### Molokai Captain Jody descriminates against The MAN

Maui Police Department officers were disciplined with suspensions ranging from one to 10 days in nine cases investigated last year, police reported.

The actions were taken for offenses including harassing a supervisor, violating terms of a no-contact order and drug use aka unauthorized use of a controlled substance. [No names released? ]

In addition to being suspended, two officers were demoted for six months - one for transporting a private citizen without authority and engaging in inappropriate behavior, and another for failing to investigate an alleged criminal offense by a subordinate officer, both in November 2007. [No names released?]

Last year there were two firings and 14 suspensions imposed as disciplinary actions, according to police. [No names released]

A summary of the incidents resulting in suspensions or firings of police officers is included in the department's annual reports submitted to the Legislature, but no mention of names of Legislators who have received the reports, and not to the Mayor of Maui County. The Mayor has no control over Maui Police Dept.

MPD chief Thomas Phillips and Molokai Captain Jody Synsack refuse to provide information to The MAN via email which makes it near impossible to obtain. Captain Jody even tells lies to justify prohibiting email communications with The MAN, claiming email about Obama's crimes were offensive to her and not work related, so she cut off email comms to all MPD police officers. She approves info given to Dispatch and socializes with her toady Todd sycophants there. Capt. Jody just returned from Nazi training in Wash. DC with the FBI, and will undoubtedly be a very loyal Obaminite for the Police State of Amerika. Makaala!

Here is the barebones information from Maui News.

Last year, 10-day suspensions were imposed in four cases, including the one in which an officer transported a private citizen without authority. In another case, an officer was suspended for 10 days, demoted for 90 days and ordered to be evaluated for fitness for duty for being insubordinate and harassing a supervisor in October 2007.

An officer was suspended for 10 days and removed from special assignment for unauthorized use of a controlled substance from 2005 to 2007. Another officer was suspended for 10 days for violating terms of a no-contact order in March 2008.

The officer who failed to properly investigate a subordinate for an alleged criminal offense was suspended for five days.

For failing to properly keep and safeguard an assigned firearm in March 2007, an officer was suspended for two days and removed from special assignment.

Three officers received one-day suspensions. One failed to complete an internal investigation of a subordinate in a timely manner in January 2007. Another officer, who also was denied extension of his assignment, failed to take appropriate action on a complaint in October 2007. In the third case, an officer also was removed from special assignment for using a department computer for inappropriate reasons in September 2007.

In 2007, the department reported firing one officer for malicious, harassing and derogatory conduct toward an arrested person in October 2006 and another officer for performing personal services while on duty and without authorization in November 2006.

The names of the officers were not made public.
