Ten Amendments to the Constitution for the United States of America Ratified effective December 15, 1791

Preamble to the Bill of Rights

The Conventions of a number of the States, having at the time of their adopting the Constitution, expressed a desire, in order to prevent misconstruction or abuse of its powers, that further declaratory and restrictive clauses should be added; And as extending the ground of public confidence in the Government, will best ensure the beneficent ends of its institution:

'Olelo Mua no ka Palapala o na Pono Pilikino o ke Kanaka

AMENDMENT I

Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

The Bill of Rights in Hawaii 2011

AMENDMENT IV

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation and particularly describing the place to be searched, and the persons or things to be seized.

forces, or in the Militia, when in actual service in time of War or public danger; nor shall any person be subject for the same offence to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation.

AMENDMENT VI

In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the State and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the Assistance of Counsel for his defence.

December 15: Bill of Rights Day in Hawaii 2011 is TODAY!



THE ANNIVERSARY OF THE BILL OF RIGHTS: Our second great national holiday -- or at least it should be. No legislative proclaimations, no media, not even government school teachers bother to mention it. Why is the government so resistant to a formal celebration of our founding freedoms from corrupt government and oppression enshirmed in our Law of the Land: The Constitution?

In the face of this unchained monster, our remaining hope against outright tyranny lies in the fact that two states, Rhode Island and North Carolina, refused to ratify that Constitution until a Bill of Rights was added -- and Massachusetts, Maryland, South Carolina, New Hampshire, Virginia and New York ratified the federal Constitution only on the condition that certain amendments be quickly added.

And so, on the day we should probably celebrate as our second great national holiday, Dec. 15, 1791, the first 10 amendments -- aka the "Bill of Prohibitions" on government conduct were ratified. The Bill of Rights is all we have left to keep us free. Today, as usual, that anniversary passed with not even a mention on the daily news and propaganda broadcasts.

Why do the folks now in charge of our national offices -- including the government schools -- pass over and ignore the historic ratification of those 462 words which have made us for two centuries the envy of men and women seeking freedom the world around -- this Bill of Rights?

Maybe because they fear folks might actually read them, and then act on them?

They're in plain English, you know. It was never intended we should need an attorney to tell us what they mean -- let alone that we should tolerate black robed "judges" telling us they don't mean what we can plainly read there for ourselves.

It couldn't be because they're afraid we'd actually go read the First Amendment, , which begins, "Congress shall make no law respecting an establishment of religion ..."?

Maybe The People would know the government is not allowed to establish some agency like the DEA, or IRS, or BATF, or Homeland Security et al, at Taxpayer expense, and issue them guns and badges, empowering them to enter onto our private property, arresting and jailing us and seizing our land and homes when no crime or injury has been committed?

Maybe the fascists running our government are afraid we'd actually go read the Second Amendment? The one that says, "A well regulated Militia being necessary to the security of a free State, the right of the people to keep and bear arms shall not be infringed"? Fascists don't like that word "free" in there, and mere people with guns?

Only a "free" country requires that the large majority of the potential armed forces consist of free, private citizens better armed than the soldiers commanded by the central government. What the Second Amendment clearly means is that -- as a guarantee against the threat of internal government tyranny -- any law-abiding American adult has a right to own and carry with him a weapon of his choice: a belt-fed .30-caliber Browning machine gun or a shoulder-launched heat-seeking missile if needed to stand up to the FBI, the ATF or the 101st Airborne for acts of treason against any Citizen of the United States of America. And where the Second Amendment says that right to keep and bear arms shall not be "infringed," that means neither the weapon, nor its ammunition, nor the buying or transport of either, may be taxed, regulated or subjected to any "permitting" process. The government can't even require that the store clerk who sells me my machine gun "check my ID," or write down my name.

A federal firearms licensed store operator in Kaunakakai reports that Maui Police Chiefs' SOP requiring permits and other infringements is so screwed up that the store has had to hold at least six hunting rifles and one .22 hand gun for law abiding customers way beyond the 14 days the MPD is allowed to finish the paperwork.

Unfortunately, our servant government people have the guns to enforce their will with treasonous actions against you.

What are you going to do about it, now on December 15, 2011, in celebration of Bill of Rights Day in Hawaii?

And what about the 10th Amendment: "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people." Maui County Fireworks Permit Schedule & Rules

WAILUKU, Maui, Hawai`i – In anticipation of a demand for fireworks permits, the Maui Fire Department is announcing its fireworks permit processing schedule.

But before people rush out and start buying their fireworks, the department asks them to be cautious and to consider the dry conditions out there.

"Although we have had some heavy rains recently, for the most part, this past year has been very dry, so the threat of wildfires is still a major concern," said MFD Capt. Paul Haake. "When using fireworks, please follow the safety tips provided, use common sense, and watch out for each other. Hopefully, we can all have a safe and enjoyable New Year's celebration and continue to celebrate every New Year with fireworks."

Fireworks permits are required to purchase the firecracker type of fireworks and are good for 5,000 firecrackers. Cost of each permit is \$25, by check or money order to the County of Maui. Permit applicants must be 18 years or older and show proof of age at the time of permit processing. Fireworks permit processing will be offered at the following locations on the following dates so GET YOUT PERMIT is FIRST STEP:

December 22-30, 2011

County Parks Permit Office - Moloka'i

First day of fireworks sales is on December 26, 2011 and that the following stores are selling permit-required firecrackers:

Misaki's and Take's Variety (Molokai)

Novelty fireworks such as sparklers, snakes, fountains and cylindrical or cone fountains which emit effects not higher than 12 feet off the ground do not require permits.

RULES

Fireworks and firecrackers can only be legally set off from 9 p.m. New Year's Eve to 1 a.m. New Year's Day.

Setting off fireworks outside designated times is punishable by law. Violators are subject to fines of up to \$2,000.

Aerial fireworks are illegal. Importing and selling aerial fireworks without a permit is a Class C Felony.

General Prohibitions

It is unlawful to remove or extract pyrotechnic contents.

It is unlawful to throw any ignited fireworks from a moving vehicle.

It is unlawful to set off fireworks within 1000 feet of health care facilities and facilities for animals.

It is unlawful to set off fireworks by schools.

It is unlawful to set off fireworks on public roads, in County parks, at County facilities, cane fields, or places of worship.

It is unlawful for any person without a permit to set off, ignite, discharge or otherwise cause to explode any fireworks within 500 feet from any hotel.

It is unlawful for any person to offer for sale, sell or give any fireworks to minors, and for any minors to possess, purchase, or set off, ignite or otherwise cause to explode any fireworks, except that the parents or guardians may allow the minor to use fireworks while under the immediate supervision and control of an adult.

Safety Tips Regarding Fireworks Use:

Fireworks can be dangerous, causing serious burns and eye injuries.

Never give fireworks, even sparklers to young children. Sparklers burn at temperatures of 2,000 degrees Fahrenheit.

Older children should use fireworks under direct supervision of an adult. Always read and follow all warnings and instructions listed by the manufacturer for the safe use and handling of fireworks.

Make sure you have a clear, flat area to use the fireworks; away from structures, dry grass or brush, and readily ignitable materials.

Have a water hose or bucket of water readily available in case of a fire. BEST way to stay safe is not to use fireworks. Read your Bible, instead.

If the Legislature bows to OHA's demands, the state will be in direct violation of the Admission Act—and contrary to OHA propaganda; it is native Hawaiians who will pay the price for OHA's power grab.

OHA's legal assault on 'ceded' lands began with a 1994 suit to prevent the State from selling about 500 acres in Lahaina to construct the Leialii affordable housing development and another approximately 1,000 acres in North Kona for the Laiopua affordable housing development near Kealakehe High School. The Hawaii Admission Act specifies five purposes for which the ceded lands "shall be" used including: "the development of farm and home ownership on as widespread a basis as possible...." HELLO! If the State cannot sell 'ceded' lands, it cannot promote "ownership" to Hawaiians.

Thousands of Hawaiians and non-Hawaiians have left Hawaii in recent years. In 2007 nearly 10,000 residents left. The primary reason for these departures is the lack of affordable housing in Hawaii. And yet the Office of Hawaiian Affairs has consumed the last 14 years seeking to prevent the construction of affordable housing on 'ceded' lands. According to OHA 'ceded' lands are to be used for the benefit of Hawaiians. In reality OHA's policy is to grab power for its Trustees by preventing the use of 'ceded;' lands for the benefit of Hawaiians and non-Hawaiians alike.

It's not just affordable housing which suffers. OHA trustees in 2007 blocked the County of Kaua'i from constructing a juvenile residential drug treatment facility near the Hanapepe Salt ponds. OHA's motivation--to again assert authority over other entities' land use decisions. As a result of OHA's actions, Hawaiian and non-Hawaiian children are not getting the help they need to get off drugs.

OHA also claims ownership of subterranean fresh water resources. OHA's grab for natural resources strangles economic opportunity. Lack of opportunity is the flip side of lack of affordable housing—together these two conditions, created by OHA, drive the continuing exodus of Hawaiians out of Hawaii. makaala!




The goal of the founders of America was to restrict government within severe limits and to protect the rights of soverign individuals. Government has NO rights!



Dhama/Congress Big Tax Hike Injust one year, the largest tax hikes in the history of America will take effect.

They will hit families and small businesses in three great waves on Jan, 2013:

First Wave: Expiration of 2001 and 2003 Tax Relief — In 2001 and 2003, the GOP Congress enacted several tax cuts for small business owners, families, and investors (later re-upped by President Obama and Democrat Congress in 2010). The following tax hikes will occur on January 1, 2013:

Personal income tax rates will rise. The top income tax rate will rise from 35 to 39.6 percent (this is also the rate at which the majority of small business profits are taxed). The lowest rate will rise from 10 to 15 percent. All the rates in between will also rise. Itemized deductions and personal exemptions will again phase out, which has the same mathematical effect as higher marginal tax rates:

- The 10% bracket rises to a new and expanded 15%
- The 25% bracket rises to 28%
- The 28% bracket rises to 31%
- The 33% bracket rises to 36%
- The 35% bracket rises to 39.6%

Higher taxes on marriage and family. The "marriage penalty" will return from the first dollar of taxable income. The child tax credit will be cut in half from \$1000 to \$500 per child. The standard deduction will no longer be doubled for married couples relative to the single level.

Middle Class Death Tax. The death tax is currently 35% with an exemption of \$5 million (\$10 million for married couples). For those dying on or after January 1 2013, there is a 55 percent top death tax rate on estates over \$1 million. A person leaving behind two homes and a retirement account could easily pass along a death tax bill to their loved ones.

Higher tax rates on savers and investors. The capital gains tax will rise from 15 percent this year to 23.8 percent in 2013. The dividends tax will rise from 15 percent this year to 43.4 percent in 2013. This is because of scheduled rate hikes plus Obamacare's investment surtax.

Second Wave: Obamacare Tax Hikes — There are twenty new or higher taxes in Obamacare. It Is the Kuleana of Public to Vindicate the Bill of Rights on This December 15, 2011

Today is Bill of Rights Day, the 220-year anniversary of this revered document's addition to the U.S. Constitution in 1791. The Anti-Federalists had demanded a Bill of Rights to ensure that the federal government created in 1789 would not morph into the type of tyranny that the American colonists had resisted in the Revolution.

It might seem like a difficult day to celebrate, however, as we consider the cur-During July 1776 the non-amendable Declaration of Independence was rent state of liberties in our nation. With the militarization of police, the erosion of requirements for search and seizure, the presidential powers used as a blanket for deplorable detention policies, the raging war on drugs, invasive TSA "security" procedures and so much else, today's governing principles at times seem to reflect the authorship of George Orwell more than that of James Madison.

U.S. history reminds us of why so many early Americans wanted a Bill of ten or unwritten. That law or system of laws or principles which defines and estabsince been corroborated by our presidents' actions time and again. Within the first decade of the new government, President John Adams turned his back completely on the First Amendment, signing the Alien and Sedition Act that criminalized critmental human rights.

War has been the greatest cause of depredations on civil liberties. During the Laws of any State to the Contrary notwithstanding. -Article VI, U.S. Constitution Civil War, President Lincoln censored the press, jailed citizens without trial, and prosecuted civilians by military commission. During World War I, President Wilson incarcerated Americans merely for criticizing the war or allied forces, going so far as to imprison Eugene Debs for speaking out against the military draft. During World War II, the Roosevelt administration put 110,000 Japanese Americans, loyal to the United States, in internment camps without any civil due process. During the Cold War, the surveillance state grew as presidents spied on political enemies and cracked down on dissent.

We see the same patterns in government as we continue to wage war on terror. In the ten years since the September 11th tragedies, we have witnessed a cascade of executive powers that flies in the face of the Bill of Rights' guarantees of fair trials, prohibitions against cruel and unusual punishment and unreasonable searches. Yet even in the last decade, politicians have pretended to uphold the unworthy of persons endowed with the philosophical limitations on government Constitution. President George W. Bush gave lip service to the Fourth Amendment on April 20, 2004:
